DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#100 is a two story brick corner shop building three bays wide and two bays in depth with a tall, one story "L" shaped wing, 1-1/2 bays wide and three bays deep and a free-standing, one story brick, one bay square former smokehouse nearby as this was formerly a butcher shop. All brickwork is in unpainted common bond. A newer doorway occupies the corner entrance which is angled to the sides. The front and side shop windows are double and quite ornate with the mullions bearing tall, attached, turned ballusters and with transoms, dentiled transom bars, and these are headed by three row header segmental arches with centered roundels and panels in the infills. Second story front windows are also double and with the same arches and infill decor. The regular arched windows of the wing have been blocked in. The front roof slopes to the rear with a front and side parapet with an overhanging wooden cornice with modillions, as in the left side of the wing. A similar cornice projects above the doorway. The wing has a shed roof. This building rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
