DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#102 is a tall, 2-1/2 story brick detached house, four bays wide and two bays in depth with a two story, two bay square brick "L" shaped wing, formerly with a side balcony and a two bay square brick extension. The simple front entrance with a newer small paned door and narrow overlight occupies the second bay from the right (W) side and is approached by a nine step porch. At the base of this porch is an old six panel Dutch door set in a paneled enframingent which leads to the pavement level cellar. All first and second story front windows are of 6/6 sash, there are two 4+4 sash casement windows lighting the front of the cellar; the wing has 2/2 sash windows and the attic is lighted by a small, four pane window in each gable. The front section has a steep slope "A" frame roof resting on three string brick cornices. Double flue enclosed chimneys rise at each end. The wings have shed roofs and all are of metal. This house rests on a low fieldstone foundation but has high brick cellar walls. It is fronted by a herringbone patterned brick pavement.
