DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a narrow two story rectangular frame building, two bays wide and approximately five bays in depth. The front section is used as a barber shop and there are side doors for the apartments. The front facade is covered by asbestos shingles, the left side by clapboarding, the right side by old embossed metal, rock-faced "blocks," and the rear by tar paper. The front shop windows are of 2/2 sash with transoms. All other windows are of 6/6 sash in old narrow frames, some with paneled shutters and others with board and batten shutters. The roof is rather flat and the boxed cornice on the front is rather ornate for this building as it is trimmed by a band of large dentils and ended by moulded brackets. The building apparently sets on a low brick foundation.
