DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#108 is a tall, detached, 2-1/2 story narrow log house, two bays wide and three bays in depth with a 1-1/2 story brick "L" shaped wing one bay wide and two bays in depth with a side balcony. The logs are now covered with asphalt shingles. An old four panel front door occupies the left (E) bay of the high first floor which is reached by a wooden porch of eight steps. Front windows are of 2/2 sash with louvered shutters. Rear windows have old small 6/6 sash with wood lintels and sills. The front section has a steep slope "A" frame roof with a double flue chimney rising on the right side. The attic is lighted by small windows in each gable. The wing has a shed roof.

The house rests on a high fieldstone foundation with a ground level board and batten door leading to the cellar. It is fronted by a brick pavement.
