DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#116 is a tall, 2-1/2 story detached brick house approximately three bays square with a two story brick "L" shaped wing approximately two bays square with a two bay square, two story frame extension and a side balcony. All brickwork is in common bond and sidewall evidence indicates this has been raised from 1-1/2 stories. A simple doorway occupies the right (W) bay with a glass over panels door, a paneled enframing, and three pane overlight. All front windows are now of 1/1 sash and those on the rear are of 6/6 sash, all with wood lintels and sills. There are four panel doors with three pane overlights on the rear. The attic is lighted by two small four pane windows in each gable. The front section has a moderate slope "A" frame roof resting on three string brick cornices and double flue enclosed chimneys rise from each end. The wing has a shed roof and both are of metal. This house sets on a rather high fieldstone foundation and brick cellar walls with the front cellar entrance, mostly above ground. This is lighted from the left side by two 4+4 sash casement windows.
