DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick detached pair of houses, four bays wide and two bays in depth. #120 has a 2-1/2 story brick "L" shaped wing, three bays deep and 1-1/2 bays wide with an enclosed side balcony and both are joined by a newer, one story, full-width lodge extension on the rear. All visible brickwork is in common bond and the front facade has been covered by formstone. Front entrances occupy the second and fourth bays from the left (E) with newer doors, but #120 retains a four pane overlight and there are newer covered porches. First floor front windows are newer, but 6/6 sash windows remain on the second story. The attics are lighted by small, four pane windows in each side and the rear gable. The front section has a moderate slope "A" frame roof resting on two string brick cornices and double flue enclosed chimneys rise from each side. The wing has a moderate slope "A" frame roof, and all are of metal. The building sets on a rather high fieldstone foundation.
