**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached pair of 2-1/2 story brick houses being five bays wide and approximately three bays in depth with a one story, full-width extension on the rear. All brickwork is in common bond. Front entrances occupy the second bay from each end with four panel doors, paneled enframements and four pane overlights. A board and batten gate with stick grillwork above protects an enclosed passageway to the rear and occupies the center bay. #119 has front windows of 6/1 sash and there are 6/6 sash remaining on the front of #121 and the rear of both houses, all with wood lintels and sills. The attics are lighted by small 6/6 sash windows with the glass now missing in each gable. The front section has a moderate slope "A" frame metal roof resting on two string brick cornices and double flue enclosed chimneys rise from each end. This building rests on a low fieldstone foundation.
