DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of houses three bays wide and two bays in depth with a full-width frame, two story extension, two bays in depth and the building is detached on the right (E) side. All brickwork is in common bond and the wing is covered by asphalt shingles. This was probably designed as one house as two doors and windows are crowded beneath the three windows above with #127 being wider. The doors are of four panels, have four pane overlights, and occupy the inner bays. First floor windows are of 2/2 sash while those on the second story front, side, and wing windows are of 6/6 sash, all with wood lintels and sills. The attic of #127 is lighted by two four pane windows in the right gable. The front section has a steep slope metal "A" frame roof resting on three string brick cornices and a double flue enclosed chimney rises at the right. This building rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
