**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick detached pair of houses being four bays wide and three bays in depth with a two story brick "T" shaped wing three bays wide and two bays in depth with side balconies, enclosed on #128, and a two story frame extension of two bays. All brickwork is in common bond. Front entrances occupy the inner bays with newer doors and three pane overlights. #128 is protected by a newer covered porch supported by Doric pillars. First floor windows are of 3/1 sash and 2/2 sash while those above 6/1 and 3/1 sash. All are headed by wood lintels with projecting end blocks and moulded tops, as above the doors. Rear windows retain their 6/6 sash with wood lintels and sills. The front section has a moderate slope "A" frame metal roof resting on two string brick cornices and with double flue enclosed chimneys rising from each side. The wing has a low slope "A" frame covered by asphalt shingles. The front attic is lighted by large windows in each gable. The building sets on a high fieldstone foundation with brick cellar walls and #130 retains a brick pavement.
