DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached pair of frame houses four bays wide and two bays in depth with a 1-1/2 story "T" shaped frame wing, three bays wide and two bays in depth, detached by a "breezeway" but joined by the roof. This building is sheathed in various types of asphalt shingles. Front entrances occupy the inner bays with #134 retaining an old four panel door and both have four pane overlights. Most house windows are of old narrow 6/6 sash. The front section has a moderate slope metal "A" frame roof with small enclosed chimneys rising from each end. The wing has a steep slope metal "A" frame roof with side overhangs and a large chimney at the end. The front attic is lighted by small windows in each gable. This building rests on a rather low fieldstone foundation and is fronted by a brick pavement.
