DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story frame detached pair of houses, four bays wide and two bays in depth with a full width, one story, one bay deep frame extension. The front is covered by aluminum siding and the sides and rear by asphalt shingles. Front entrances occupy the inner bays with glass/panel doors and old four pane overlights. First floor front windows are now 6/1 sash but the upper story and rear area windows retain 6/6 sash. The attic is lighted by a small window in each gable. The building has a moderate slope metal "A" frame roof with small enclosed chimneys rising at each end. It rests on a low foundation and is fronted by a brick pavement.
