DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#143 is a two story frame house two bays wide and three bays in depth with an "L" shaped, one story, one bay square frame addition. The house has been completely sheathed in aluminum siding. The small paned door occupies the right (E) bay with a narrow, two pane overlight. Most house windows are now of 1/1 sash with one 6/6 on the rear. The front boxed cornice is decorated by incised lozenges and a row of dentils. It rests on a low foundation.
