DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick detached pair of houses four bays wide and three bays in depth with a two story brick "T" shaped wing, three bays wide and two bays in depth with side balconies. All brickwork is in common bond. Simple front entrances occupy the inner bays with #144 retaining a four panel door and both have four pane overlights. All house windows are of 6/6 sash with newer brick soldier course arches on the front and wood lintels and sills on the rear. The metal roofs of the front section and wing slope to the rear. The overhanging front roof cornice is decorated by Victorian cut, finely scrolled and closely spaced brackets. This building rests on a low fieldstone foundation and is fronted by a brick pavement.
