DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This large double house, with the two units separated at the first floor level by an enclosed rear passage, has had only minor alterations made to it. The most obvious of these is a large, flat roofed, shingled dormer, centered on the front slope of the gable roof. The house is of brick construction on a high foundation wall the encloses two full cellars. The street facade is four bays wide with entrances occupying the second and last bays from the east end. Above are four evenly spaced windows; all windows are of 1/1 sash and the doors are transformed. Each opening has a moulded wood lintel. There is a three string stepped brick cornice and a single interior chimney at each end of the roof ridge.
