DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story attached brick pair of houses being five bays wide and approximately three bays in depth with a two story brick pair of "U" shaped wings two bays deep and one bay wide with a one story brick and frame extension. All brickwork is in common bond. Simple front entrances occupy the second bay from each end with newer doors, and #162 retains a three pane overlight. These are reached by high, six step brick porches. An enclosed passageway to the rear yards lies in the center bay. All front windows are now of 1/1 sash with wood sills and moulded top lintels. Rear area windows of 162 are of 6/6 sash and 2/2 sash with #164 having 1/1 sash, all with wood sills and lintels. There is a newer shed roof triple window dormer with 2/2 sash and dentil trim on the front of #164, and each house has a six pane shed roofed dormer window on the rear. The front section has a moderate slope "A" frame roof resting on three string brick cornices and double flue enclosed chimneys rise from each gable. This building sets on a high field-stone foundation with brick cellar walls halfway above ground.
