DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of two story brick houses, four bays wide and three bays in depth with a two story frame "T" shaped wing, two bays square. All brickwork is in common bond and the wing is covered by old board and batten siding. Simple front entranceways occupy the second and fourth bays from the right (E) side with four panel doors and three pane overlights. All house windows are of 6/6 sash with wood lintels and sills and there are four panel doors on the rear. The front section roof slopes to the rear and the wing has a low "A" frame roof, both of metal. The front roofline has an overhanging boxed cornice with brackets decorated by turned pendants dividing and ending the bays. This building rests on a low fieldstone foundation and is fronted by a brick pavement.
