DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#169 is a two story detached brick house, two bays wide and one bay in depth with a two story brick "L" shaped wing 1-1/2 bays wide and approximately six bays in depth with the last three bays being three bays wide. All brickwork is in common bond. The front entranceway occupies the left (W) bay with a glass over panels door and a two row header brick segmental arch with centered roundels and panels in the infill, as do all front windows. The first floor window is unusual with a pair of tall 5+5 pane vertical casements. Most other house windows are of 2/2 sash with wood lintels and sills. The front section roof slopes to the rear and the wing has a shed roof. The overhanging front roof cornice is supported by three finely cut, channeled and scrolled brackets with the frieze decorated with a slanted section of large incised lozenges and a band of tall dentils. The house rests on a low fieldstone foundation and is fronted by a heringbone patterned brick pavement.
