DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#171 is a low two story detached brick house four bays wide and approximately five bays in depth with enclosed rear galleries. This house sets back from the regular building line and is fronted by a herringbone pavement with a grass plot and evergreens protected by an ornate cast iron gate and wrought iron fence. The front walls are of common bond with the side walls stuccoed on what the owner claims to be stone walls. A newer front door occupies the left bay. All house windows are of 1/1 sash with wood lintels and sills. The metal roof slopes to the rear and is fronted by a moulded cornice. The house rests on a low fieldstone foundation.
