DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached two story pair of houses of frame construction, four bays wide and four longer bays in depth. The front is now covered by aluminum siding with the sides and rear by asphalt shingles. Simple glass over panel doors occupy the front inner bays with wide 1/1 sash windows on each side. Second story front and rear area windows are of 2/2 sash. The roof slopes to the rear and is fronted by an overhanging boxed cornice supported by three small Victorian cut brackets dividing and ending the houses and a band of dentils top the frieze. This house rests on a high fieldstone foundation with porches of six steps.
