DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#176 is a 2-1/2 story frame house with the gable facing the street and is two bays wide, approximately four bays deep and with a rear balcony. This closely resembles several houses on W. Seventh Street of that type, and is sheathed with clapboarding. A newer door occupies the left (E) bay and all house windows are of 6/1 sash with moulded top lintels, as above the door. The front pediment is covered by asbestos shingles with a square window of three vertical panes lighting the attic. The moderate slope "A" frame metal roof extends to the rear and is fronted by a plain overhanging boxed cornice. The house rests on a low concrete block foundation. It sets back from the street with a grass plot at the front.
