DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#179 is a tall detached 2-1/2 story brick house three bays wide and two bays in depth with a two story brick "L" shaped wing two bays wide and five bays in depth with a side balcony and a three bay deep, two story brick rear extension. All brickwork is in common bond. The front entranceway occupies the left (W) bay with double doors of glass, white marble sill, and a segmental arched transom with a dentiled transom bar. All front and most rear area windows are of 1/1 sash with those on the front having three row header segmental arches and rear windows have wood lintels and sills. There is a four panel kitchen door with a narrow overlight. The attic is lighted by small four pane windows in each gable. The front section has an asphalt covered, moderate slope "A" frame roof with double flue enclosed chimneys rising from each end. The wing has a shed roof. A boxed cornice fronts the roofline and is decorated by a band of dentils and ending by Victorian cut and fluted brackets. This house rests on a rather low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
