DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached pair of brick houses four bays wide and two bays in depth with a 2-1/2 story brick "T" shaped wing three bays square with side balconies and a new block extension to the rear of #183. All brickwork is of common bond. Newer glass paned doors with narrow overlights occupy the outer bays. Front windows are mostly 6/1 sash and the wing retains 6/6 sash, all with wood lintels and sills. The attics are lighted by a small four pane window in each gable. The front section has a steep slope "A" frame roof resting on two string brick cornices with small enclosed chimneys rising from each end. The wing has a wide moderate slope "A" frame roof with a triple flue enclosed chimney at the rear. The building rests on a rather low fieldstone foundation.
