while the upper story front windows are of 1/1 each with two row header segmented arches and brick header sills. Rear and side windows vary from 4/4, 6/4 and 6/6 with both wood lintels and sills and two row header segmented arches. The metal roof is relatively flat, sloping slightly to the left to accommodate clerestory type windows on the interior for light. A very large rectangular brick chimney enclosed is located in the left rear corner. The front facade rises to form a parapet and is decorated by a three string recessed row of bricks. The building is set on a very low fieldstone foundation. The interior is undistinguished except for chamfered T shaped beams which support the floors and a freight elevator. The original wood floors remain however all walls have been covered by plywood paneling.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a very large, three story brick rectangular building attached to #115. It is five bays wide and fourteen bays in depth. It has had many uses over the years. Brickwork is of painted common bond. The first floor front has windows and doors of modern construction while the upper story front windows are of 1/1 sash with two row header segmental arches and brick header sills. Rear and side windows vary from 4/4, 6/4 and 6/6 with both wood lintels and sills and two row header segmental arches. The metal roof is relatively flat, sloping slightly to the left with a very large rectangular chimney enclosed in the left rear corner. The front facade rises to form a parapet and is decorated by a three string recessed row of bricks. The building is set on a very low fieldstone foundation.
