DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a row of four small 1-1/2 story brick houses detached on the left (N) side, eight bays wide and two bays in depth with the end houses having quaint one story, one bay square "L" shaped brick wings with steep shed roofs and overhangs. #26 and 28 share a small "T" shaped, one story brick wing, one bay deep and two bays wide of similar design. All brickwork is in common bond. Simple front entrances occupy the second and third and sixth and seventh bays from the left with four panel doors and narrow overlights. There are enclosed passageways to rear yards between the pairs of front doors. All house windows are of 2/2 sash with wood lintels and sills and louvered shutters on the front. There are also four panel kitchen doors. The attic of #24 is lighted by a small four pane window in the left gable. The front section has a moderate slope, slate "A" frame roof resting on two string brick cornices. Small enclosed chimneys rise from each end with a double flue chimney rising from the center on the ridge. The building rests on a low fieldstone foundation.
