**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a tall, 2-1/2 story brick pair of houses, four bays wide and two bays in depth with a 1-1/2 story brick "T" shaped wing, three bays wide and two bays in depth with a shed continuation of the front section roof sloping to the rear. All brickwork is in common bond. Newer doors occupy the second and fourth bays from the left (S) side with four pane overlights. The front windows are of small 6/6 sash with moulded top lintels as above the doors. Rear windows are also of 6/6 sash and there are several old board and batten doors. The attics of the wings are lighted by a 6/3 sash window on each side and the front section attics have tall, narrow windows on each side. The front section has a steep slope metal "A" frame roof resting on a two string brick cornice on the front and continuing at the same slope down across the rear wing in the old colonial "Catslide" manner. Small enclosed chimneys rise from each end and a wide chimney rises through the roof at the center rear of the front section. This building sets on a high field-stone and brick foundation with the cellars mostly above ground.
