DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached brick pair of houses four bays wide and approximately three bays in depth with a two story brick "T" shaped wing, three bays wide and two bays in depth with side balconies. All brickwork is in common bond. Simple segmental arched front entrances with old four panel doors and narrow overlights occupy the inner bays. Front windows now have 1/1 sash and rear area windows have 2/2 sash, all with two row header segmental arches, as do the doors. The front section has a broad and high steep slope "A" frame roof resting on two string brick cornices with the front cornice unusual, with rounded bricks  . Small chimneys rise from each gable. The wing has a low slope "A" frame  roof and both are of metal. This building rests on a low fieldstone foundation and is fronted by a brick pavement.
