DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a small detached 2-1/2 story pair of frame houses, possibly of logs, four small bays wide and two bays in depth. It is now sheathed in clapboarding. There is a new one story, full-width wing to the rear. Newer doors occupy the inner bays and front windows are mostly of 6/6 sash, but there are none on the rear of the front section. The front section has a steep slope, metal "A" frame roof with no visible chimneys. This building sets on a high fieldstone foundation.
