DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a small brick pair of 1-1/2 story houses detached from others, four bays wide and two bays in depth with a new, one story rear wing of nearly full width. All brickwork is in common bond. This house formerly had a frame "T" shaped wing with a steep slope "A" frame roof. Simple front entrances occupy the outer bays with old four panel doors and three pane overlights. First floor windows are of 9/9 sash with narrow muntins and upper story windows on the front and rear are of sliding 4+4 casement "lie on your stomach" sash, all with wood lintels and sills.

The front section has a moderate slope "A" frame metal roof resting on two string brick cornices, and there is a massive central chimney. The building sets on a high fieldstone foundation and is fronted by a brick pavement.
