

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a tall, three story, rectangular brick building detached on the right side. It is four bays wide and approximately six bays in depth. All brickwork is in common bond and the front has been recently restored. The first floor now contains a rather classical shop front with Doric attached pillars supporting a frieze containing a paneled sign plate covered by a moulded cornice which extends across the building. The design of this building is one of the few that puts the emphasis on structure, beginning with the pillars dividing the bays on the first floor and continuing up through the upper stories by brick piers. In between these are 1/1 sash windows with those on the second story having transoms of a very small and intricate design of colored leaded glass. All windows are tied together at the heads and bases by bands of brownstone with the heads being carved in ~~the~~^a centre ogee design.  The brickwork framing the windows is very ornate with the bricks having small attached column sections at the corners  on every other row giving the appearance of bisected pillars. The front facade is topped by a shallow mansard section with a decorative tear drop band and interspersed by ornate pediments over the inner piers and by square capped blocks over the end piers. These piers are further emphasized by being beveled out at the top and by square caps over each at the top of the mansard section. The remainder of the roof is fairly flat. The building rests on a low foundation.
