DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a tall, rectangular three story brick attached building, three large bays wide and approximately five bays in depth. All brickwork is in common bond with the front faced with a small pressed brick. THE first floor has been altered with newer shop windows of large panes enclosed in colonial framing. The upper stories display the original, very ornate, masonry work. The front facade is divided by story and bay with wide terra cotta pilasters with panels running vertically and on the horizontal with decorative bosses. The enclosed bay windows of large panes. At the top of these two story bay window walls are segmental brick arches in recessed bands and adorned by projecting keystones moulded in a floral pattern relief. The pressed brick facing is of a brown shade with the terra cotta trim matching it. The very ornate masonry cornice is supported by fluted and moulded paired brackets in the same pattern as over the window walls and is decorated by large modillions, rows of dentils and the frieze is ornated by a wide band of garlands interspersed with bosses of lion heads and human heads, all in high relief. Capping the front facade is a flat brick parapet with piers. In the center is a panel with the name "ROSENSTOCK BLDG" carved in relief. The roof slopes to the rear with stepped side walls. The building has a low foundation.
