DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is now a detached, two story brick rectangular building. It is three bays wide and seven bays in depth. The second story and front facade were added c1929 from what had been a 1-1/2 story building with a Greek pediment facade decorated with heavy molding and dentil trim. Original brick work rises to the second story on the sides and rear of the building and is of an orange hue. The present front facade is of small, dark red pressed brick. The first floor is occupied by a monument business and contains regular large paved shop windows with entrance doors to the shop and apartments above. There is an original large paneled door with a high small paned overlight with a wood lintel in the right side wall. The second floor front contains two 20th century bay windows with 1/1 sash. The first floor side windows are original 12/12 sash with wood lintels and either wood or cement sills. This type had also been on the original front facade. A balcony runs across the rear of the building. The metal roof slopes gently toward the rear. There is a simple molded cornice with dentil trim cantilevered from the wall at the base of the parapet. This building stands on a very low fieldstone foundation.
