

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick attached former house, five bays wide and two bays in depth with an "L" shaped brick wing on the right side joined at the rear by another two story brick "L" shaped wing forming a quadrangle with the adjoining building on the left and leaving a second story patio area of about four bays square, as the first floor area has been extended to the rear. All brickwork is in common bond and the front facade has been completely altered and refaced. This is now divided into two shops of newer construction, the original entrance and a covered passageway to the rear, both in the left two bays. The original house entrance in the second bay from the left has a rather plain three part doorway with a glass door, long side panes over panels and large panes above. This is topped by a two row header segmental brick arch decorated by a carved roundel in the infill, as are all front second story windows, one on the rear and the enclosed passageway arch. This passageway is protected by a board and batten gate with a Victorian stick grillwork panel above. Over the main doorway is a newer bay window with panels and 1/1 sash as are all other front second floor windows. These are protected by louvered shutters. The front section attic is well lighted by two round arched 2/2 sash dormer windows on the front with stepped gables. On the rear of this roof are regular peaked dormers of 2/2 sash. The wing sections have 6/6 sash windows, four panel doors, and a board and batten door, all at the second story level. The front section has a moderate slope metal roof with a wide enclosed chimney rising from the right gable and a smaller one on the left. The wing roofs are rather flat. The front roofline and the rear of the front section both have boxed cornices with the front being adorned by scrolled dentils and moulding. On the residence side, an old well-designed stairway ascends all the way to the attic. The owner states that a tinsmith had a shop in the rear section wing which was reached by the enclosed passageway. The building sets on a low fieldstone foundation.
