DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick attached building of a rectangular shape being four bays wide and approximately six bays long. The front facade appears to be laid in Flemish bond beneath many coats of paint. The first floor front now has large paned shop windows covered by a brood signplate and a cornice. Upper story front windows are of 2/2 sash with segmental brick arches as are those on the rear of the third story. The roof slopes gently to the midsection and then becomes a shed roof. The front roofline has a very ornamental Victorian cornice consisting of closely spaced 1/4 round brackets decorated with horizontal reeding and sections of incised decor in between. On each end are paired brackets of the same design. The frieze is decorated by a broad panel of small lozenges and bands of roping and dentils. There is a balcony on the rear of the third story. The building rests on a low foundation.
