**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a three story brick building detached on the right and is three bays wide and four in depth with a three story brick, full width extension of three bays and a one story brick extension with a frame second story and a third story covered porch. There are also several concrete block extensions to the rear. All brickwork is in common bond with the front and first section side facades more recently faced. The first floor front now has large paned windows, a corrugated aluminum signplate and aluminum pilasters. There is a two story bay window in the left bay with 1/1 sash, dentil trim, fluted pilasters, and unusual moulded bases. To the right are 1/1 sash windows moulded stepped cornices on the second story, and flat moulded cornices on the third story. Side windows are all of 1/1 sash with wood lintels and sills. The roof of the front section slopes to the rear and those of the wings are low slope shed roofs. The front roof cornice is moulded with square modillions, and reeded end brackets which have square floral motif bosses and which support square urns tipped by wing-like finials. The frieze has recessed panels with incized lozenge decor. The building rests on a low foundation.
