DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick detached building three bays wide and approximately four bays in depth with a brick, two story "L" shaped wing approximately six bays long and two bays wide, a wing side extension and a first floor extension. All brickwork is in common bond. The first floor front has been altered into an attractive shop area and apartment entrance with a new unpainted brick facing topped by a wooden cornice. The upper stories have a very ornate Victorian styling with segmental arched windows framed by paneling and topped by square headed cornices containing moulded pediments and scrollwork at the centers. The windows are of 2/2 sash except for those on the second story end bays which are 1/3 higher and have 2/4 sash. Original windows on the rear sections are of 6/6 sash with wood lintels and sills. The front section roof slopes to the rear with stepped side walls and the wing has a metal shed roof. The front roofline is decorated by a moulded cornice, supported by richly moulded brackets topped by large square urns at the ends, and above the roofline. The raised wooden frieze contains a band of sharks teeth , rows of moulding, and panels centered by diamond shaped designs between the brackets. The building rests on a low foundation.
