**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a large, three story brick pair of buildings detached on the right side and is nine narrow bays wide. #26 is approximately ten bays long with several brick or block extensions to the rear. #28 (three bays wide) is five bays long with a five bay deep, two story extension. All brickwork is common bond which has been recently restored and there is no seam dividing the front facade. There are star brace terminals on the exposed side wall. The first floor area has large paned windows. Those on the upper stories have round arched 1/1 sash windows with three row brick header hood moulds. Three string belt courses cross the building at the busses of the window arches. The rooflines are fairly flat and the front is edged by a moulded cornice with modillions and a band of dentils on the raised wooden frieze which is moulded at the top and bottom. The building rests on a low foundation.
