DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick building detached on the right side. It is three bays wide and approximately five bays in depth with a one story full width wing four bays in depth and several second story frame additions covered by asbestos shingles and with rear balconies. This building was raised from 2-1/2 stories according to side brickwork evidence and the front facade is laid in Flemish bond through the second story. The first floor front is occupied by vacant offices with large pane windows and a side apartment entrance, all headed by a dentiled cornice. Upper story front windows are of 1/1 sash with wood lintels and sills and rear area windows are of either 6/6 sash or unusual four vertical sash over one sash windows. The front section roof slopes to the rear and the wings have shed roofs. The front roof cornice is decorated by moulding, dentils and lozenges with moulded brackets at the ends. The building sets on a low foundation.
