**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a three story brick building attached on the right side and is five bays wide and two bays deep with a 2-1/2 story four bays long, two bays wide "T" shaped wing with balconies on either side. All brickwork is of common bond. The main doorway occupies the central bay and is entered by a paneled door, high one pane overlight and surrounded by a molded architrave. A more recent doorway of cheaper construction has been added to the left end bay, probably replacing a window, making the building into a duplex. Front windows are of 2/2 sash with flat brick arches with the first floor having 1/1 sash. Side and rear windows are of 6/6 sash with wood lintels and sills. Side and rear doors are paneled and have three pane overlights. There is one 8/8 sash horizontal window. The front section roofline slopes down to the wing which has a moderate slope "A" frame and both are of metal. There are two double chimneys on the wing roof. A bracketed cornice with a  design like others in this block, adorns the front roofline. The building rests on a fairly low foundation.
