DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is basically a two story brick attached, rectangular building with a shallow front "mansard" third story section of asphalt tiles which becomes a long slope shed roof to the rear. All brickwork is in common bond. It is approximately three bays wide by five bays in depth. The first floor front contains an apartment entrance and a shop area with a large show window of small panes, all covered by a moulded cornice. Second story front windows are in two pairs of 6/6 sash, with segmental two row brick header arches. The rear area now gives no indication of age. The front roofline has a simple box cornice. The building sets on a low foundation.
