DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick building detached on the left side, approximately four bays wide and twelve bays deep. All brickwork is in common bond and the front is faced with an unpainted dark red pressed brick. This front facade is occupied by a storefront with tall vertical panes and paneled sections above and below. On the second story level are double windows of 1/1 sash topped by soldier course brick lintels as over the first floor window areas. The front wall is topped by a parapet with concrete urns and a center sphere. Rear area windows are of either 6/6 or 1/1 with wood lintels and sills. The roof is rather flat. There are star building brace terminals in the side walls. The building sets on a low foundation.
