DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a three story brick detached building approximately four bays square with a three story brick wing, slightly wider and four bays in depth, with rear galleries and several newer one story extensions. The front brickwork is laid in Flemish bond through the second story and the right side wall gives evidence of an original 2-1/2 story house with a small attic window. There are star and lozenge shaped building brace terminals in the right wall. The first floor contains a shop with large paned windows in the right bays and an apartment entrance on the left with the whole being covered by a simple moulded cornice. A wide, two story bay window rises in the right bays with 1/1 sash and the usual dentil and moulding trim. Other front windows are of 1/1 sash with flat brick arches. Rear area windows are a combination of 1/1, 2/2, 6/6, and 9/9 sash with wood lintels and sills. The roof of the front section slopes to the rear and the wing has a rather flat roof. The front roofline is edged by a deep moulded cornice supported by heavy cyma curved moulded brackets with bosses in a crossed floral motif. The raised wood frieze is decorated by lintels and half circle floral patterns. The building sets on a low fieldstone foundation.
