**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 3-1/2 story brick attached building approximately four bays wide and two bays in depth with a two story brick, full width wing containing a frame third story. This is three bays in depth with rear galleries. All brickwork is in common bond. The first floor front is occupied by large paned shop windows and an apartment entrance in the right bay. All are headed by a moulded boxed cornice. Upper floors have a two story, very wide bay window with panels and dentil trim in the center bays. On either side are 1/1 sash windows with wood lintels adorned by end blocks carved with roundels, as above the apartment's entrance. Rear windows are of 6/6 sash with wood lintels and sills. The front section has a one bay deep steep slope roof of asbestos shingles and the rear section becomes a long metal shed roof. A small chimney is enclosed in the right wall. The front roofline rests on a three string brick cornice. This building sets on a rather low foundation.
