

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is now a three story brick attached house, four bays wide and two bays in depth, with a two bay wide, seven bay long "L" shaped wing with a side balcony. All brickwork is of painted common bond. The front doorway occupies the left bay and an enclosed passageway to the yard is on the right. The double doors are very attractive with paneling enclosing hand crafted designs and are surmounted by a segmental arched overlight and framed by a Federal style flat entablature supported by fluted brackets and paneled pilasters. This is reached by a three step brown-stone porch. Upper story windows on the front are of 2/2 sash with louvered shutters and molded wooden lintels and sills. The first floor windows of 1/1 sash are topped by entablatures with trim matching that of the doorway. On the rear section are two Federal-Colonial style JIB windows (panes in the top and paneled door sections in the bottom). There are also 12/12 sash, 6/6 sash and 2/2 sash with paneled shutters, wood lintels and sills. The front roof slopes gently down to the wing which has a shed roof, all being of metal. A 6/6 sash dormer lights the attic cornice with a repeated "U" design identical to others in this area, adorns the roofline. The house rests on a fairly low foundation, probably of fieldstone.

STATEMENT OF SIGNIFICANCE

This was originally a Federal style 2-1/2 story townhouse. It was purchased in 1859 by Augustus L. Eader who added the wing and top floors. This was once a fashionable neighborhood of spacious elegant townhouses around the late 19th century. The house has been occupied by the same family since 1859, now being lived in by Mrs. Dorothy Eader Crutchley, a granddaughter, and the interior should prove to be a good example for restorers of Federal homes.
