DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick attached building approximately three bays square with a 2-1/2 story brick "L" shaped wing four bays long and two bays wide with a side balcony and a one story one bay square extension. All brickwork is in common bond with the front faced in a sand colored brick. The front entrance occupies the left bay with a rather new door of small panes over panels, set in an old paneled enframement with a four pane overlight. All front windows are of 6/6 sash with newer flat brick soldier course lintels and concrete sills as on #107. The entrance is approached by a four step porch with a wrought iron railing. The wing also has 6/6 sash windows but with the original wood lintels and sills. There are glass panel doors with old four pane overlights. The wing attic is lighted by a 6/6 sash window in the rear gable. The front section has a moderate slope "A" frame roof with two enclosed double flue chimneys on the right side and the wing has a steep slope shed roof and both are of asphalt shingles. The front roofline has a simple boxed cornice. The building sets on a high foundation.
