DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick building detached on the right side and three bays wide, four bays long, with no wing or balcony. All brickwork is in common bond with the front faced in sand colored brick. The front facade appears to be newer than side and rear walls and has a larger pane shopfront in the right bays with a plain apartment entrance with a newer glass over panels door in the left bay. The second story contains a 6/1 sash triple window with fluted mullions and a smaller 1/1 sash window, both with flat brick soldier course lintels and concrete sills. The front facade is capped by a stepped parapet decorated with a four string brick course with dentils. All side and rear windows are also of 6/1 sash but headed by two row header brick segmental arches. The roof slopes to the rear with side wall parapets. The building sets on a low foundation.
