**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick detached house three bays square with a two story "L" shaped brick wing four bays long and two bays wide with a side balcony, a two story brick, two bays square extension and a one story, one bay square dependency extension. All brickwork is of common bond with the front recently restored. There are star brace terminals on the side walls. The front entranceway occupies the left bay with a six panel door with a transom and is approached by a four step granite porch with wrought iron railings. All front windows are now of 1/1 sash with louvered shutters and moulded top wood lintels with unusual scrolled wood carvings above against the brickwork. Rear windows are of 6/6 sash with wood lintels and sills and the rear of the front section has old 6/6 JIB window-doors on both floors. There are four panel doors with four pane overlights and the dependency has two board and batten doors side by side. The attic is lighted by a 6/6 sash window in the right gable and the wing has a 3/6 sash on the rear. The front section has a moderate slope "A" frame roof with two double flue chimneys joined by a curtain rising from the right gable. The wing has a steep slope shed roof and both are of metal. The front and rear rooflines have boxed cornices. The building rests on a high fieldstone foundation.
