**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick house detached on the left side. It is three bays wide and two in depth with an "L" shaped two story brick wing five bays long and two bays wide with a side balcony and newer brick and block construction to the rear and side. All brickwork is in common bond. The front entranceway occupies the right bay with a glass over panels door which is approached by a three step granite porch with a wrought iron railing. To the left is a large plate glass window replacing two former house windows with flat brick jack arches as those above which are now of 1/1 sash. Wing windows are of 2/2 sash with wood lintels and sills. The attic is lighted by a 2/2 sash window in the left gable. The front section has a steep slope "A" frame roof covered by slate with small enclosed chimneys rising from the gables. The right side chimney has been reduced to a stump. The roof is supported on the front by a three string brick cornice with the second row dentiled and by a two stringer at the rear. The wing has a metal shed roof. The building sets on a high fieldstone foundation.
