DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a brick, three story corner building, five bays wide and three bays deep with a three bay wide, four bay long, two story wing along the side street. There is a balcony along the rear. All brickwork is of common bond. The front doorway lies in the center bay with paneled decorated double doors surmounted by a half round overlight. Framing this is a flat entablature supported by decorated brackets and attached narrow pillars. Most windows are of 2/2 sash with double row brick header arches - round on the front and segmental on the right side facade. Window heads are decorated with three roundels and incised scrollwork. The front section roof slopes to the rear with stepped side walls and the wing has a shed roof, both of metal. A bracketed cornice edges the front roofline and is decorated in Victorian Era square motifs and a wooden frieze with pierced designs. A store now occupies the corner of the property but the date of its origin is uncertain. The building sits on a moderately high foundation, probably of fieldstone.
