**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a three story three bay square brick house detached on the left side. It has a two story brick "L" shaped wing two bays square and a three bay long extension with a long side balcony. All brickwork is in common bond. The front entrance-way occupies the right bay with a four panel door with ovals, a rectangular transom, paneled enframing and a granite sill. This is approached by a white marble two step porch with oldstyle wrought iron railings with large lyre motifs. All front windows are now of 1/1 sash and have moulded top lintels and louvered shutters. Third story windows are shorter than those on the first story. Rear windows are either of 1/1 or 2/2 sash with wood lintels and sills and doors have glass over panels. The front section roof slopes to the rear and the wing has a shed roof with both of metal. Enclosed double flue chimneys rise from each side wall. The front roofline is adorned by a simple moulded cornice. The building rests on a low foundation.
