DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is basically a 2-1/2 story Federal home of brick, but the front slope of the "A" frame roof was built out to form a Victorian mansard roof, resulting in a three story front facade. It is approximately three bays square with a two story brick "L" shaped wing six bays long and two bays wide. All brickwork is of common bond. The front entranceway occupies the left bay with double doors of glass, a rectangular transom with a moulded transom bar, paneled enframing, Doric pilasters, and headed by a flat entablature with dentil trim and a moulded bar. This is approached by a three step granite porch with cast and wrought iron railings and an old gas lamp lights the porch from the side. All front windows are of 6/1 sash with Federal style flat brick arches. Rear area windows are of 6/6 sash with wood lintels and sills and two 10+10 casement windows are set in the rear wall of the wing. There are rear area four panel doors with overlights. The front mansard section is lighted by two dormer windows of 6/1 sash, topped by pediments with returns. A moulded cornice divides this area from the lower stories. The front mansard is covered with slate and the rear slope is that of a steep "A" framing with the side walls stepped. The wing has a shed roof of metal as is the rear of the front section. The house rests on a rather low foundation with a seven step basement front entrance.
